### SEDBERGH PARISH COUNCIL - Conditions relating to the issue of Car Parking Permits

1. Annual Parking Permits are valid for use at Joss Lane and Loftus Hill car parks. This does not include the long vehicle and coach bays at Joss Lane Car Park. The permits are specific to the vehicle, the registration number of which is displayed on the permit, and are valid from 1st September to the 31st of August the following year. It is the responsibility of the holder to apply for a replacement at the end of the valid period. Reminders will not be sent to permit holders.
2. Permits should be clearly displayed in the front windscreen of the vehicle to which they apply. Failure to do so may result in the issue of a fixed penalty notice.
3. Parking of the vehicle in either car park is subject to the conditions displayed at each car park, except for those relating to the charging policies. Failure to adhere to this policy will result in the withdrawal of the permit and parking fees will need to be paid in line with the daily charges shown.
4. Permits will not be issued for any vehicle that does not fit in the marked bays. **The use of the car park for storage of any vehicle is specifically excluded.** Permits will only be issued for camper vans in exceptional circumstances. A special application must be made to the Chairman of the Parish Council.
5. Permits are not transferable to another vehicle. A replacement permit for a vehicle with a different registration number can be applied for without charge on return of the existing permit.
6. A reduced fee will be charged for any year if the application is made after the 1<sup>st</sup> April. An Annual Permit does not guarantee a space in either of the car parks.
7. The Parish Council retains the right to withdraw a parking permit from, or refuse to issue a parking permit to, anyone who fails to adhere to these conditions.
